



**CT COUNCIL ON SOIL AND WATER CONSERVATION
NRCS TSP R² PROGRAM
Training Participant Agreement**

This Agreement is made between the Connecticut Council on Soil and Water Conservation ("CSWC") and the undersigned Connecticut forest practitioner ("Participant") regarding participation in year one, commencing in February 2026, of the NRCS TSP R² Program ("Program").

Participant Commitment:

To become a Technical Service Provider ("TSP"), participants shall complete all three training sessions, submit a reviewed and approved forest management plan (FMP), and complete TSP registration. Less is required for current TSPs to complete this Program. Please see the table below that details requirements based on TSP status.

Participants may begin the Program and opt out of completing the Program. Payment will only be issued following the completion of each required training session or step.

To receive payment, the participant shall attend the individual training session in its entirety. Partial attendance in any individual training will not qualify for payment. Time commitments are detailed on the table below.

Participant Compensation:

CSWC will pay each participant \$115 per hour for complete training attendance. Payment will be issued following each completed training session or step. A participant therefore may receive three rounds of



payment. Compensation for each training or step is detailed in the table below. Lunch will be provided at the in-person training sessions.

The maximum payment per participant in the training sessions is one thousand eight hundred forty dollars (\$1,840), which represents payment for sixteen (16) hours of in-person training. The sixteen (16) hours is comprised of TSP TRAINING, PART 1 (six (6) hrs.), TSP Training PART 2 (two (2) hrs.), and the TSP ORIENTATION & CONSERVATION PLANNING TRAINING (eight (8) hrs.). TSP Recruits who complete, submit, and receive NRCS approval for a forest management plan (FMP) **and** who register as a TSP will receive an additional two thousand five hundred dollars (\$2,500) flat payment, provided that such FMP is submitted ideally within six months (by July 31, 2026) but no later than December 31, 2026.

Total maximum payment per TSP recruit in year one is four thousand three hundred forty dollars (\$4,340), which is comprised of sixteen (16) hours of training and one approved FMP and registration as TSP.

Payment Schedule:

Hourly payments for training sessions shall be issued by check from CSWC to the participant within sixty (60) days after completion of each training and mailed to the participant, at the address provided by the participant below:

Payment for an approved FMP and completed TSP registration will be issued by CSWC to the participant within sixty (60) days of NRCS' verification of such participant's TSP registration.

Participation & Registration:

Participation is limited to twenty (20) spots per session. An additional five (5) spots will be held on a waitlist. Waitlisted participants will be notified via email regarding their status and will be contacted by CSWC if a spot becomes available. If a spot does not become available for a waitlisted participant, they will need to register again for year two of the Program. Registration is on a first-come, first-served basis.

Participant acknowledges that this program is funded through June 1, 2029, and offers 3 full rounds of trainings. Participants may choose to spread their attendance across multiple years or retake trainings in subsequent years if funding allows and should plan accordingly.

Participants shall bring their own computer or tablet to the training sessions. If a participant requires assistance or does not have access to a device, **the participant shall inform the CSWC within fourteen (14) days of the scheduled training** so that CSWC can provide support to ensure participation.
